504 New Rochelle Road (Gas station/Convenience store):

- Up and operating; no word of problems so far.
- Currently operating under a Temporary Certificate of Compliance (TCC), since there are still a few minor loose ends to be tied up, specifically: pavement markings and signage at the entrance and exits to be added, Town's lighting consultant scheduled to do field check of all light fixtures, light levels and all instructions for which lights can and cannot remain on after operating hours, TCC good until October 8, but should be ready for Final CC shortly

<u>493 New Rochelle Road</u> (former Chase bank): No inquiries at all since the last report; previous inquiries regarding the potential for coffee shops/fast food -- but nothing concrete ever materialized (and those are not generally allowed anyway).

490 New Rochelle Road (former bakery): No news or inquiries about potential tenants (and the renovations appear to have slowed down a bit).

<u>Road Construction</u>: As we know, the local area road closures due to resurfacing/construction are becoming overwhelming. We understand some (or maybe most) of this is related to a gas pipeline project that extends as far north as Canada, and the portion running through our area (mostly on California Road) is up for repair at this time. But it's been going on for months in the same spot, roads are frequently closed, and with all the construction traffic New Rochelle Road has become a potholed mess.

Information from Hector (Supt. of Highways) and Lisa Pinto in the Supervisor's Office: Project about two months behind schedule due to technical difficulties found with the pipe under the initial section of California Road. This current section should be done by 9/30/18. The rest of it will take until about August 2019 to get to Mill Road. California Road to be paved as soon as possible. However, New Rochelle Road is not "owned" by the Town of Eastchester, so Town presently waiting to hear back on that.
