    - There have not been any complaints about the site, except for excessive signage as discussed at least CHCA meeting; the signage has since been removed
  - 493 New Rochelle Road (former Chase bank)

### 490 New Rochelle Road (former bakery):

- Certificate of Compliance issued for smaller storefront. No word as to potential tenants.
- Work on the larger, former bakery storefront has stalled; no indication as to when work will be complete. The permits do expire, but can be extended simply by paying additional fees

#### 497 New Rochelle Road (Sunoco Station):

• Because the owner did not meet the required deadlines, the Town issued a summons and the owner appeared in court. The Court allowed him additional time to rectify removal of the wood pile, shed and lift. Owner has removed most, if not all, of the wood, dissembled the lift (but not yet removed it), and is in the process of finding a new home for the shed. Once the Town issues a summons, there is not much leeway with deadlines; however, owner is making progress and is scheduled to appear in court again on July 2 (at which time, it is hoped all issues will have been resolved).
